Technical bulletin - Unic crane and safety issue

This is a technical bulletin, one with a safety warning, issued to keep members aware of lessons learned the hard way.

There was a recent incident, just prior to Christmas 2006, in which an operator was using a Unic crane (mini crawler) remote control. The crane was working from a slab above the remote control operator which effectively meant that the operator couldn't see the crane. He was working blind.

On the operator's command the wire rope paid out of the drum, extended fully and then started to wind back onto the drum in the reverse direction.

This reversal caused the wire

rope anchor to fail and the wire rope detached from the crane. All operators are reminded that there should always be three turns left on the drum and therefore the operator MUST be in sight of the drum or the crane MUST be positioned so that the wire rope cannot be fully extended.

Drum protection kits are available from the cranes' agents and these can be retro fitted. It's also understood that all machines now imported will have the protection kits fitted as standard. It's recommended that all owners of these cranes take appropriate steps to prevent this type of incident happening.

Endorsement programme

Members of the Crane Association will have an endorsement programme, even if few have contributed towards its makeup. The Council will develop the programme based on its own ideas of what it should contain. Don't worry however, if you were about to contribute ideas, we do live in a democracy, and once the draft is available it will be circulated to all members for comments.

The programme is something that needs the enthusiastic support of members to succeed so please contribute your ideas and criticisms once the draft has been released.

New Rules

We are required to file a new set of Association rules with the companies office as part of the final process of the name change.

You have all had the first draft and the solicitors are preparing a final version taking into account comments received. The revised draft will be sent to members and will be debated at the annual general meeting on 13 July. Once agreement is reached the rules will be filed with the companies office.

This will wrap up the rebranding and renaming we've undertaken and it's full steam ahead.

Code of Practice for Cranes

Already I can hear the groans and yes, you would be correct if you thought - "I bet this still hasn't gone to the Minister". As we pointed out in the February newsletter, the Department of Labour has heard the views of a number of interested parties (including 26 of our members who invested a lot of time and very well-reasoned argument). Departmental officials now propose that the Code will be sent to the Minister for approval - after a final draft is circulated for comment by industry. This will go with a proviso that officials and representatives of

officials and representatives of interested parties will form a working group to look at the question of what could best be described as "major" and "minor" inspections.

We'll keep the membership informed of progress (if any)! Our goal is clarification of two important sections of the regulations: the design life of cranes and clarification of rules governing the importation of used trucks with truck loader cranes fitted from Japan.
